# SEXUAL ASSAULT DEFINED

**Sexual Assault is criminal conduct** that falls well short of the standards America expects of its men and women in uniform and is a violation of our Air Force Core Values.

**Sexual Assault** is defined as intentional sexual conduct, characterized by use of force, physical threat or abuse of authority or when the victim does not or cannot consent. Sexual assault includes rape, nonconsensual sodomy (oral or anal sex), indecent assault (unwanted, inappropriate sexual contact or fondling), or attempts to commit these acts. Sexual assault can occur without regard to gender or spousal relationship or age of victim.

**Consent** shall not be deemed or construed to mean the failure by the victim to offer physical resistance. Consent is not given when a person uses force, threat of force, coercion or when the victim is asleep, incapacitated, or unconscious.

## **REPORTING OPTIONS**

The Air Force has instituted new avenues for reporting sexual assault in the form of Restricted and Unrestricted Reporting. Restricted Reporting allows a victim to report a Sexual Assault without triggering an investigation. It is intended to give the victim (survivor) time and control over the release of their information. Further, it also

**Unrestricted reporting** is any report of sexual assault made through normal reporting channels (for example: reports to chain of command, security forces, and/or Air Force Office of Investigation). All active duty members, dependents 18 and older and civilians who have independent access to the base are eligible.

Police investigation will ensue and commander will be notified by SARC in a private and confidential manner. Your Information will be handled discreetly by your commander and those with an official need to know. SARC will intervene and will be actively involved to help with your needs. You will receive: medical care, evidence collected, victim advocate and legal assistance. Your report CANNOT go Restricted. Restricted Reporting is intended to give the victim (survivor) time and control over the release of their information. Further, it also empowers the survivor to make an informed decision about participating in the criminal process.

**Restricted reporting** is available to active duty military and dependents 18 and older, and civilian employees. For confidentiality, your report will be taken by the SARC, who will not contact police or your commander. Evidence can be collected, and you will receive medical care, a victim advocate and legal assistance. This report CAN go Unrestricted at any time.

The CATCH Program gives people making a Restricted Report, an Unrestricted Report with an unknown or unidentified suspect, or a veteran an opportunity to anonymously disclose suspect information to help the Department of Defense identify serial offenders. CATCH allows sexual assault victims (Service members and adult dependents) to discover if the suspect may have also assaulted another person (a "match" in the CATCH

**Sexual Harassment reporting** options (unrestricted and restricted) are now available for active-duty members who have experienced unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct that is sexual in nature. When the incident occurs in the work environment and is a condition of the individual's employment, effects the individual's work performance, or creates an intimidating, hostile, or offensive work environment individuals may file a restricted or unrestricted report with the SAPR Office. Installation Equal Opportunity (EO) offices will continue to process sexual harassment complaints in accordance with DAFI 36-2710. Confidentiality applies to all SAPR services.

## SAPR VOLUNTEER OPPORTUNITIES

SAPR TEAL Program, Trained Educated Airman Liaison is a new volunteer program at Minot AFB for those who are interested in combatting sexual assault and "continuum of harm behaviors" in the military. SAPR TEAL volunteers will serve as liaisons from the SAPR Office to the unit to increase program engagement to support resources, participate in unit and community awareness and prevention events, provide peer to peer connection, support both sexual assault and sexual harassment concerns, assist in trainings and briefings, and more!
